INSTRUCTIONS FOR COMPILING THE REGISTRATION FORM AND THE PAYMENT OF THE ASSOCIATION FEE

Registration for Club Italia 6.5 is valid for a calendar year, registrations and their renewals will expire on December 31st of the year for which they were presented.

Applications for initial enrollment and renewal of entries can be made from 1 December the previous year up to the 31 March of the membership year.

At its discretion, the Board of Directors may decide to also consider and accept registrations submitted after March 31, possibly placing limitations on the applicant's written rights (eg limitation of the right to vote at the meeting or in any facilities offered by the Club to members).

COMPILING AND SENDING THE MODULE

The applicant is required to fill in the registration form in all its parts legibly and to sign in the appropriate spaces, the first for the registration request to the Club, the second for consent to the processing of personal data. The scanned signed form (in pdf or jpeg format), must only be sent by e-mail to: segreteria@seipuntocinque.com

The application will be refused if the mandatory data is not completed.

The applicant can make payment of the fee after communication of acceptance by the secretariat or, in absence, after 10 days from the request. Any payments made in advance, in case of refusal, will be reimbursed net of expenses.

INFORMATION ON THE PURPOSES OF ART. 13-14 OF THE GDPR (GENERAL DATA PROTECTION REGULATION) 2016/679

The processing of personal data will be based on the law on the principles of correctness, lawfulness, transparency and protection of your privacy and your rights. According to article 13 of the GDPR 2016/679, therefore, we provide you with the following information:

Personal data (name, surname, telephone number, e-mail address, address of residence, place and date of birth, Fiscal Code, details of the Recognition Document, etc.) will be provided at the time of application for membership of the Association.

The personal data provided will be subject to:

in relation to legal, tax, insurance and statutory obligations:

- of activities related to the institutional purposes exerted by the Association;
- activities aimed at making participation possible in the Association which, among other things, may involve the dissemination of personal data in social bulletins periodically published and disseminated online;
- of activities for the collection and payment of registration, insurance and event registration fees for any national affiliation bodies, also deriving from specific agreements with them;
- of activities aimed at administrative, fiscal and accounting obligations of the Association itself (including the issue of receipts, the production of telematic certifications, the keeping of the register of the Associates etc etc).

In relation to the need for profiling and communication of the activities of the Association:

- of activities connected to the need to understand, for the achievement of the common institutional purposes, which are the most suitable activities for the members / members / users / clients;
- of activities connected to the need to propose the most suitable activities to the members / members / users / customers;

Personal data is kept for the entire duration of the Association and / or mandate relationship and, in the case of revocation and / or other type of termination of the relationship, within the prescribed terms indicated in the art. 2220 of the Civil Code.

You can, at any time, exercise the rights:

- access to personal data;
- to obtain the correction or cancellation of the same or the limitation of the processing that concern him in cases where this does not conflict with other provisions of law;
- to oppose the process;
- to oppose data portability;
- to revoke the consent, where provided in cases where this does not conflict with other provisions of law: the withdrawal of consent does not affect the lawfulness of the treatment of data based on the consent granted before the revocation;
- to propose a complaint to the supervisory authority (Privacy Guarantor).
